Review recap of the Commission's Informal Officer Succession Plan

Background:

The Commission has three officers, no two of whom can be from the same county:

- 1. Chair
- 2. Vice-Chair
- 3. Secretary

Traditionally, the Commission has rotated its officers among the large and less populated counties to achieve a balance in the governance of the program.

In general, the Chair, Vice-Chair, and Secretary have been rotated every two years with each office represented by a different county. For example, the Chair may be from Anoka for two years, the Vice- Chair from a less populated county such as Scott, and the Secretary from Dakota. In 2007 the Commission recognized that Carver County was not part of the rotation. They also determined that population should not be a consideration in officer succession and opted for a straight rotation of officers including Carver.

As of December 31, 2022, the Chair from Hennepin County was finishing the second of two years. The Vice-Chair from Washington County was finishing the second of two years and the Secretary from Ramsey County was finishing the second of two years. Under our normal succession, the rotation for chair would be as follows:

Service Years	County Representation	
2023 and 2024	Washington	
2025 and 2026	Ramsey	
2027 and 2028	Carver	
2029 and 2030	Anoka	
2031 and 2032	Scott	
2033 and 2034	Dakota	
2035 and 2026	Hennepin	

The Executive Committee is made up of the three officers plus one member from each of the counties not represented by an officer.
