Business Administrator Arleen Schacht has announced her retirement, effective mid-June 2025. Minnesota Statute 473.704, Subdivision 4, outlines the powers and duties of the MMCD Commission, stating: "It may employ and fix the duties and compensation for a business administrator who shall administer the business affairs of the commission."

At the March 2025 Executive Committee meeting, Commissioner Miron offered the following resolution and moved its adoption:

Resolved, the Executive Director is directed to lead an internal committee to review applications, conduct interviews, and select a final candidate to be presented to the Executive Committee and Commission for approval.

Commissioner Anderson seconded the motion. The resolution was approved unanimously.

In May 2025, an internal committee reviewed applications, conducted interviews, and completed reference checks for the final candidate.

We are pleased to recommend the appointment of **Maria Mancilla-Diaz** to the position of Business Administrator, contingent upon the successful completion of a criminal background check.

Maria currently serves as Chief Administrative Officer for Southwest Transit in Eden Prairie.
